Place: Castellon, 1-2 July 2021

In this meeting the partners discussed the results of the need analysis and defined the list of topics and practices essential for implementing digital social inclusion initiatives / activities. DAY 1 - 01 July 2021

The participants arrived at FUE-UJI venue at 11:30 and at 12:00 started the meeting with the welcome by the host institution and analysis of the Agenda.

Conclusion: *Take into account what was written in the application form add what is missing in the Google drive of the project.*

At 18:00 The conclusions about digital competences were discussed :

Conclusion: The next report (Digital competences analysis) will be organised in 4 sections with a general overview based on the review of official bibliography about each topic (not focusing on their countries):

- “Professional engagement” and “Digital resources” Turkey will be responsible for writing it (4 pages each section).
- “Teaching and learning” and “Assessment“, Spain will be responsible for writing it (4 pages each section).
- “Empowering learners”, Check Republic will be responsible for writing it (4 pages)
- “Facilitating learners’ Digital Competence”, Poland will be responsible for writing it (4 pages)

DAY 2 - 02 July 2021

The second day meeting started at 9:00 with a welcome coffee

The topics to be presented in the workshop was discussed and Javier gave an introduction about the ASIDE dissemination in the IMAT 2021 Congress

About 10:00 – 11:00 Social media and active education workshop took place. The ASIDE consortium meeting has been a key opportunity for the celebration of the International Workshop of the project, in which the cases on digital needs of social services of each country participating in the project (Poland, Turkey, Spain and Czech Republic) have been presented. This workshop was held online on 2 July and brought together more than 30 participants. The report to the workshop will be written in other document.

11:00 AM the partners discussed about Quality management and ITC assure to present for the next meeting a short document.

Exchange of good practices took place after Project QM.

Conclusion:

- COVID period increase the digital skills on seniors ‘seniors use social media’ not only for non-formal education but also for communication with the group. The question is: would this mean that the senior population has lost the fear of digitalization?
- Digitalization needs infrastructures, is your infrastructure ready to support your ‘government strategy and action plan’?
- Is still underdeveloped. How to overcome that? We have to use them and invest more.
- We share so many personal information in digital platforms. what is the security level about these databases?.
- In Spain, in last month, there is a phone number that solves problems related to cyberattacks and related to digitalization of taxes
